This refers to your license amendment request dated April 26, 2018. Please find enclosed Amendment No. 41 adding the temporary mobile van and your new hot lab to allow for construction of new facilities within your nuclear medicine department. To support release of the mobile van and your current nuclear medicine facilities for unrestricted use, following construction, please submit closeout surveys for all areas requested, including the van, and confirmation of receipt of sealed sources by Alliance.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
