This letter refers to the license amendment request dated May 31, 2018. Please find enclosed Amendment No. 9 authorizing the removal of the possession and use of radioactive material at the facilities located at 345 North Main Street, West Hartford, Connecticut. The facilities may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
