As Dr. Nickens explained, the purpose of these formats is to acquire consistent and standardized information for each place revisited or discovered during the upcoming Tribal field survey. However, each Tribal field crew is free to record their own notes during the course of the fieldwork. We are happy to talk further with the Tribes about the forms on Monday.
