Dear Mr. Stamm:

This concerns your license amendment request dated April 20, 2018, to add a storage location at 1762 Watterson Trail, Louisville, Kentucky. Byproduct material storage locations on an NRC license can only be for locations in non-agreement states or other locations that are under exclusive Federal jurisdiction (see Section 2 of NUREG-1556, Vol. 1, Rev. 2, "Consolidated Guidance About Materials Licenses, Program-Specific Guidance About Portable Gauge Licenses"). The location requested falls under the jurisdiction of the State of Kentucky, an Agreement State, and therefore you must apply for a radiation materials license with them or amend an existing State of Kentucky license for the location you requested. For these reasons we have voided your request. This action is taken without prejudice to the resubmission of your request.
