**Re: Update to Notice of Planned Closure: Kennett HMA, Inc. d/b/a Twin Rivers Regional Medical Center (License No. 24-17628-01)**

Dear Sir or Madam:

I write on behalf of Kennett HMA, LLC, which owns and operates Twin Rivers Regional Medical Center, a general acute care hospital in Kennett, Missouri (the "Hospital"). The Hospital holds the above-referenced U.S. Nuclear Regulatory Commission ("NRC") Materials License ("License"). As you know, we previously provided notice of the Hospital's planned cessation of operations as a licensed holder of nuclear materials effective as of July 1, 2018. The purpose of this letter is to inform you that the Hospital will now cease operations effective as of 12:01 a.m. local time June 12, 2018. Physicians who are currently covering the Hospital's emergency room have given notice that they will not practice at the Hospital after June 11, 2018. Accordingly, in-patient, emergency room, and hospital-based outpatient services will no longer be available as of June 12, 2018.

All transition activities have been accelerated to account for the change in timeline. We understand that the NRC requires the submission of certain information related to the winding up of the Hospital's affairs. Please be advised that the Hospital will furnish the information requested by the NRC under separate cover.

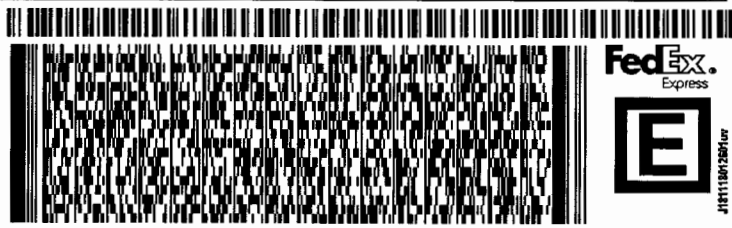

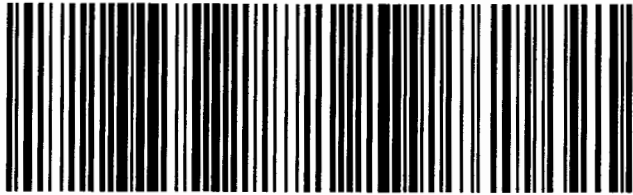
