Dear NRC Representative:

We would like to amend the above license to remove the location at **1000 East 101st Terrace, Kansas City, Missouri** from our license.

All licensed activity at this site has ceased effective April 30, 2018. All radioactive waste that was being decayed in storage has been removed following verification that waste measured background with survey meters. All check sources have been removed from the location and returned to the manufacturer using FedEx. Last dates of use for the radiopharmaceuticals at this site are summarized below:

Zevalin total dose is based on 32 R/hr-mCi at the mouth of an open Y-90 vial, assumed to be 1cm.						

Due to the short half-lives, low activity used, and the dates of last use if an entire dose of each radiopharmaceutical were spilled on the date of last use no member of the public would be likely to receive more than 25 mrem in one year. A final radiation survey was conducted of the facility which confirmed all radioactive material had been removed and that any remaining residual activity is within limits specified by 10 CFR 20.1402.

We plan to continue radioactive materials licensed activities at the following locations:




