1. Is the proposed collection of information necessary for the NRC to properly perform its functions? Does the information have practical utility?

We were unable to answer this question.

2. Is the burden estimate accurate?

This information is compiled in a different format for senior management review, so the additional time to reformat it to send to the NRC is about two hours.

3. Is there a way to enhance the quality, utility, and clarity of the information to be collected?

The current format provides for sufficient information quality and clarity.

4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?

Considering the small information collection burden (about two hours) the use of automated data collection is not considered necessary.
