This refers to your license amendment request submitted by Malgorzata Kouretas dated May 3, 2018, and May 14, 2018. Please find enclosed Amendment No. 35 authorizing the radiological survey plans for the Former Dog Pound Area and the Building 22 land area. The plan titled "MARSSIM Survey and Sampling Plan, Former Dog Pound Area," in the letter dated May 3, 2018, and amended in the letter dated June 5, 2018, is accepted. The plan titled, "MARSSIM Final Status Survey and Sampling Work Plan – Radiological Survey and Sampling Area 22," in the letter dated May 14, 2018 is accepted. Please submit the results of these surveys once completed.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).
