9 NECESSITY, FUNCTION, AND CONFORMITY: KRS 211.844 requires the Cabinet
10 for Health and Family Services to promulgate administrative regulations for the
11 registration and licensing of the possession or use of sources of ionizing or electronic
12 product radiation and the handling and disposal of radioactive waste. This administrative
13 regulation establishes requirements and provisions for the use of byproduct [~~radioactive~~]
14 material in the healing arts, for issuance of licenses authorizing the medical use of
15 byproduct [~~radioactive~~] material and for specific licensees to possess, use, and transfer
16 byproduct [~~radioactive~~] material for medical uses.

17 Section 1. Definitions. (1) "Cabinet" is defined by KRS 194A.005(1).

18 (2) "Licensee" means a person who holds:

19 (a) A specific license issued by the cabinet pursuant to 902 KAR 100:040 and this
20 administrative regulation;

21 (b) A specific license issued by the U.S. Nuclear Regulatory Commission or an

1 Agreement State; or

2 (c) A general license pursuant to 902 KAR 100:050 or equivalent regulations of the
3 U.S. Nuclear Regulatory Commission or an Agreement State

4 Section 2. Applicability. This administrative regulation establishes requirements for the
5 medical use of byproduct material and for issuance of specific licensees authorizing the
6 use of this material [~~to possess, use or transfer radioactive material for licenses of broad~~
7 ~~scope]. Except as established in subsections (1) through (4) of this section, the licensee~~
8 shall comply with 10 C.F.R. Part 35.

9 (1) The licensee shall not be subject to:

10 (a) 10 C.F.R. 35.8;

11 (b) 10 C.F.R. 35.11(c)(1);

12 (c) 10 C.F.R. 35.13(a)(1);

13 (d) 10 C.F.R. 35.4001; and

14 (e) 10 C.F.R. 35.4002.

15 (2) Application for specific license. Each application for a specific license shall be filed
16 pursuant to 902 KAR 100:040.

17 (3) The "Cabinet for Health and Family Services, Department for Public Health, Radiation
18 Health Branch" shall be used in lieu of federal references to the "Commission" and the "NRC."

19 (4) Notifications and reports required by 10 C.F.R. 35.14, 35.3045, 35.3047, and
20 35.3067 shall be directed to the manager, Radiation Health Branch, at:

2 this subsection. [~~Implementation. (1) A licensee shall implement the provisions in this~~
3 ~~administrative regulation on or before October 24, 2005, with the exception of the~~
4 ~~requirements listed in subsection (2) of this section.~~

5 ~~(2) A licensee shall implement the training requirements in Sections 63, 64, 65, 66, 67,~~
6 ~~68, 69, 70, 71, 72, 73, 74, 75, 76, and 77 of this administrative regulation on or before~~
7 ~~October 25, 2007.~~

8 ~~(3) Prior to October 25, 2007, a licensee shall satisfy the training requirements of this~~
9 ~~administrative regulation for a radiation safety officer, an authorized medical physicist, an~~
10 ~~authorized nuclear pharmacist, or an authorized user by complying with either:~~

11 ~~(a) The appropriate training requirements in Sections 63, 64, 65, 66, 67, 68, 69, 70,~~
12 ~~71, 72, 73, 74, 75, 76, and 77 of this administrative regulation; or~~

13 ~~(b) The appropriate training requirements in Section 78 of this administrative~~
14 ~~regulation.~~

15 ~~(4) If a license condition exempted a licensee from a provision of this administrative~~
16 ~~regulation on October 24, 2005, then the license condition continues to exempt the~~
17 ~~licensee from the provision of 902 KAR 100:072.~~

18 ~~(5) If a requirement in this administrative regulation differs from the requirement in an~~
19 ~~existing license condition, the requirement in this administrative regulation shall govern.~~

20 ~~(6) A licensee shall continue to comply with any license condition that requires it to~~
21 ~~implement procedures required by Sections 49, 55, 56, and 57 of this administrative~~
22 ~~regulation until there is a license amendment or renewal that modifies the license~~
23 ~~condition.~~

1 ~~Section 2. License Required. (1) A person may manufacture, produce, acquire,~~
2 ~~receive, possess, prepare, use, or transfer radioactive material for medical use only in~~
3 ~~accordance with a specific license issued by the cabinet, the U.S. Nuclear Regulatory~~
4 ~~Commission, or another agreement state, or as allowed in subsection (2)(a) or (b) of this~~
5 ~~section.~~

6 ~~(2) A specific license is not required for an individual who:~~

7 ~~(a) Receives, possesses, uses, or transfers radioactive material in accordance with~~
8 ~~the administrative regulations in this chapter under the supervision of an authorized user~~
9 ~~as provided in Section 12 of this administrative regulation unless prohibited by license~~
10 ~~condition; or~~

11 ~~(b) Prepares unsealed radioactive material for medical use in accordance with the~~
12 ~~administrative regulations in this chapter under the supervision of an authorized nuclear~~
13 ~~pharmacist or authorized user as provided in Section 12 of this administrative regulation~~
14 ~~unless prohibited by license condition.~~

15 ~~Section 3. Maintenance of Records. Each record required by this administrative~~
16 ~~regulation shall be legible throughout the retention period specified by each section. The~~
17 ~~record shall be the original or a reproduced copy or a microform if the copy or microform~~
18 ~~is authenticated by authorized personnel and the microform is capable of producing a~~
19 ~~clear copy throughout the required retention period. The record may also be stored in~~
20 ~~electronic media with the capability for producing legible, accurate, and complete records~~
21 ~~during the required retention period. Records such as letters, drawings, and specifications~~
22 ~~shall include all pertinent information such as stamps, initials, and signatures. The~~
23 ~~licensee shall maintain adequate safeguards against tampering with and loss of records.~~

1 ~~Section 4. Application for License, Amendment, or Renewal. (1) An application shall~~
2 ~~be signed by the applicant's or licensee's management.~~

3 ~~(2) An application for a license for medical use of radioactive material as described in~~
4 ~~Sections 30, 31, 33, 37, 45, 46 and 62 of this administrative regulation and shall be made~~
5 ~~by:~~

6 ~~(a) Filing an original and one (1) copy of Form RPS-7, Application for Radioactive~~
7 ~~Material License, that includes the facility diagram, equipment, and training and~~
8 ~~experience qualifications of the radiation safety officer, authorized user, authorized~~
9 ~~medical physicist, and authorized nuclear pharmacist; and~~

10 ~~(b) Submitting procedures required by Sections 49, 55, 56, and 57, of this~~
11 ~~administrative regulation as applicable.~~

12 ~~(3) A request for a license amendment or renewal shall be made by:~~

13 ~~(a) Submitting an original and one (1) copy of either:~~

14 ~~1. Form RPS-7, Application for Radioactive Material License; or~~

15 ~~2. A letter requesting the amendment or renewal; and~~

16 ~~(b) Submitting procedures required by Sections 49, 55, 56, and 57 of this~~

18 ~~(4) In addition to the requirements in subsections (2) and (3) of this section, an~~

- 1 ~~1. Radiation safety precautions and instructions;~~
- 2 ~~2. Methodology for measurement of dosages or doses to be administered to patients~~
- 3 ~~or human research subjects; and~~
- 4 ~~3. Calibration, maintenance, and repair of instruments and equipment necessary for~~
- 5 ~~radiation safety.~~

6 ~~(b) The applicant or licensee shall provide information requested by the cabinet as~~
7 ~~necessary to complete its review of the application.~~

8 ~~(5) An applicant that satisfies the requirements specified in 902 KAR 100:052 of this~~
9 ~~chapter may apply for a Type A specific license of broad scope.~~

10 ~~Section 5. License Amendments. A licensee shall apply for and receive a license~~
11 ~~amendment:~~

12 ~~(1) Before the licensee receives, prepares, or uses radioactive material for a type of~~
13 ~~use that is permitted under this chapter, but that is not authorized on the licensee's current~~
14 ~~license issued under this chapter;~~

15 ~~(2) Before the licensee permits anyone to work as an authorized user, authorized~~
16 ~~nuclear pharmacist, or authorized medical physicist under the license, except:~~

17 ~~(a) For an authorized user, an individual who meets the requirements in Sections 63,~~
18 ~~68(1), 69(1), 70(1), 71(1), 72(1), 74(1), 76(1), 77(1), 78(2)(a), 78(3)(a), 78(4)(a), 78(7)(a),~~
19 ~~78(9)(a), and 78(10)(a) of this administrative regulation;~~

20 ~~(b) For an authorized nuclear pharmacist, an individual who meets the requirements~~
21 ~~in Sections 63 and 66(1) or 78(12)(a);~~

22 ~~(c) For an authorized medical physicist, an individual who meets the requirements in~~
23 ~~Sections 63 and 65(1) or 78(11)(a) or (b) of this administrative regulation;~~

1 ~~(d) An individual who is identified as an authorized user, an authorized nuclear~~
2 ~~pharmacist, or authorized medical physicist:~~

3 ~~1. On a cabinet, an agreement state, or U.S. Nuclear Regulatory Commission license~~
4 ~~or other equivalent permit or license recognized by the cabinet that authorizes the use of~~
5 ~~radioactive material in medical use or in the practice of nuclear pharmacy;~~

6 ~~2. On a permit issued by the cabinet, an agreement state, or U.S. Nuclear Regulatory~~
7 ~~Commission specific license of broad scope that is authorized to permit the use of~~
8 ~~radioactive material in medical use or in the practice of nuclear pharmacy;~~

9 ~~3. On a permit issued by a U.S. Nuclear Regulatory Commission master material~~
10 ~~licensee that is authorized to permit the use of radioactive material in medical use or in~~
11 ~~the practice of nuclear pharmacy; or~~

12 ~~4. By a commercial nuclear pharmacy that has been authorized to identify authorized~~
13 ~~nuclear pharmacists.~~

14 ~~(3) Before it changes radiation safety officers, except as provided in Section 10(3) of~~
15 ~~this administrative regulation;~~

16 ~~(4) Before it receives radioactive material in excess of the amount or in a different~~
17 ~~form, or receives a different radionuclide than is authorized on the license;~~

18 ~~(5) Before it adds to or changes the areas of use identified in the application or on the~~
19 ~~license, except for areas of use where radioactive material is used only in accordance~~
20 ~~with either Section 30 or 31 of this administrative regulation;~~

21 ~~(6) Before it changes the address of use identified in the application or on the license;~~
22 ~~or~~

23 ~~(7) Before it revises procedures required by Sections 49, 55, 56 and 57 of this~~

1 ~~administrative regulation as applicable, where the revision reduces radiation safety; and~~
2 ~~(8) Before conducting research involving human research subjects using radioactive~~
3 ~~material.~~

4 ~~Section 6. Notifications. (1) A licensee shall provide the cabinet a copy of the board~~
5 ~~certification, the cabinet, U.S. Nuclear Regulatory Commission or agreement state~~
6 ~~license, the permit issued by a U.S. Nuclear Regulatory Commission master material~~
7 ~~licensee, the permit issued by a cabinet, U.S. Nuclear Regulatory Commission, or~~
8 ~~equivalent agreement state licensee of broad scope, or the permit issued by a U.S.~~
9 ~~Nuclear Regulatory Commission master material license broad scope permittee for each~~
10 ~~individual no later than thirty (30) days after the date that the licensee permits the~~
11 ~~individual to work as an authorized user, an authorized nuclear pharmacist, or an~~
12 ~~authorized medical physicist under Section 5(2)(a) through (d) of this administrative~~
13 ~~regulation.~~

14 ~~(2) A licensee shall notify the cabinet by letter no later than thirty (30) days after:~~

15 ~~(a) An authorized user, an authorized nuclear pharmacist, a radiation safety officer,~~
16 ~~or an authorized medical physicist permanently discontinues performance of duties under~~
17 ~~the license or has a name change;~~

18 ~~(b) The licensee's mailing address changes;~~

19 ~~(c) The licensee's name changes, but the name change does not constitute a transfer~~
20 ~~of control of the license as described in 902 KAR 100:040, Section 6(2) of this chapter;~~

21 ~~or~~

22 ~~(d) The licensee has added to or changed the areas of use identified in the application~~
23 ~~or on the license if radioactive material is used in accordance with either Section 30 or 31~~

1 of this administrative regulation.

5 ~~Section 7. Exemptions Regarding Type A Specific Licenses of Broad Scope. A~~
6 ~~licensee possessing a Type A specific license of broad scope for medical use, issued~~
7 ~~under 902 KAR 100:052 of this chapter, is exempt from:~~

8 (1) ~~Section 4(4) of this administrative regulation regarding the need to file an~~
9 ~~amendment to the license for medical use of radioactive material, as described in Section~~
10 ~~62 of this administrative regulation;~~

11 (2) ~~The provisions of Section 5(2) of this administrative regulation;~~

23 ~~Section 8. License Issuance. (1) The cabinet shall issue a license for the medical use~~

1 of radioactive material if:

2 (a) ~~The applicant has filed RPS-7 Application for Radioactive Material License in~~
3 ~~accordance with the instructions in Section 4 of this administrative regulation;~~

4 (b) ~~The applicant has paid any applicable fee as provided in 902 KAR 100:012 of this~~
5 ~~chapter;~~

6 (c) ~~The cabinet finds the applicant equipped and committed to observe the safety~~
7 ~~standards established by the cabinet in this Chapter for the protection of the public health~~
8 ~~and safety; and~~

9 (d) ~~The applicant meets the requirements of 902 KAR 100:040, 100:041, 100:042,~~
10 ~~and 100:045 of this chapter.~~

11 (2) ~~The cabinet shall issue a license for mobile medical service if the applicant:~~

12 (a) ~~Meets the requirements in subsection (1) of this section; and~~

13 (b) ~~Assures that individuals or human research subjects to whom unsealed radioactive~~
14 ~~material or radiation from implants containing radioactive material will be administered~~
15 ~~may be released following treatment in accordance with Section 27 of this administrative~~
16 ~~regulation.~~

17 ~~Section 9. Specific Exemptions. The cabinet may, as established in 10 C.F.R. 35.19,~~
18 ~~upon application of any interested person or upon its own initiative, grant exemptions from~~
19 ~~the administrative regulations in this chapter that it determines are authorized by law and~~
20 ~~will not endanger life or property or the common defense and security and are otherwise~~
21 ~~in the public interest.~~

22 ~~Section 10. Authority and Responsibilities for the Radiation Protection Program. (1)~~
23 ~~In addition to the radiation protection program requirements of 902 KAR 100:019 of this~~

1 ~~administrative regulation, a licensee's management shall approve in writing:~~

2 ~~(a) Requests for a license application, renewal, or amendment before submittal to the~~
3 ~~cabinet;~~

4 ~~(b) Any individual before allowing that individual to work as an authorized user,~~
5 ~~authorized nuclear pharmacist, or authorized medical physicist; and~~

6 ~~(c) Radiation protection program changes that do not require a license amendment~~
7 ~~and are permitted in under Section 11 of this administrative regulation.~~

8 ~~(2) A licensee's management shall appoint a radiation safety officer, who agrees, in~~
9 ~~writing, to be responsible for implementing the radiation protection program. The licensee,~~
10 ~~through the radiation safety officer, shall ensure that radiation safety activities are being~~
11 ~~performed in accordance with licensee approved procedures and regulatory~~
12 ~~requirements.~~

13 ~~(3) For up to sixty (60) days each year, a licensee may permit an authorized user or~~
14 ~~an individual qualified to be a radiation safety officer, under Sections 63 and 64, of this~~
15 ~~administrative regulation to function as a temporary radiation safety officer and to perform~~
16 ~~the functions of a radiation safety officer, as provided in subsection (7) of this section, if~~
17 ~~the licensee takes the actions required in subsections (2), (5), (7), and (8) of this section~~
18 ~~and notifies the cabinet in accordance with Section 6 of this administrative regulation.~~

19 ~~(4) A licensee may simultaneously appoint more than one (1) temporary radiation~~
20 ~~safety officer in accordance with subsection (3) of this section, if needed to ensure that~~
21 ~~the licensee has a temporary radiation safety officer that satisfies the requirements to be~~
22 ~~a radiation safety officer for each of the different types of uses of radioactive material~~
23 ~~permitted by the license.~~

1 ~~(5) A licensee shall establish the authority, duties, and responsibilities of the radiation~~
2 ~~safety officer in writing.~~

3 ~~(6) A licensee authorized for two (2) or more different types of uses of radioactive~~
4 ~~material under Sections 33, 37, and 46 of this administrative regulation or two (2) or more~~
5 ~~types of units under Section 46 of this administrative regulation shall establish a Radiation~~
6 ~~Safety Committee to oversee all uses of radioactive material permitted by the license.~~
7 ~~The committee shall include an authorized user of each type of use permitted by the~~
8 ~~license, the radiation safety officer, a representative of the nursing service, and a~~
9 ~~representative of management who is neither an authorized user nor a radiation safety~~
10 ~~officer. The committee may include other members the licensee considers appropriate.~~

11 ~~(7) A licensee shall provide the radiation safety officer sufficient authority,~~
12 ~~organizational freedom, time, resources, and management prerogative to:~~

13 ~~(a) Identify radiation safety problems;~~

14 ~~(b) Initiate, recommend, or provide corrective actions;~~

15 ~~(c) Stop unsafe operations; and~~

16 ~~(d) Verify implementation of corrective actions.~~

17 ~~(8) A licensee shall retain a record of actions taken under subsections (1), (2), and (5)~~
18 ~~of this section as follows:~~

19 ~~(a) A licensee shall retain a record of actions taken by the licensee's management in~~
20 ~~accordance with subsection (1) of this section, for five (5) years. The record shall include~~
21 ~~a summary of the actions taken and a signature of licensee management.~~

22 ~~(b) The licensee shall retain a copy of both authority, duties, and responsibilities of~~
23 ~~the radiation safety officer, as required in subsection (5) of this section, and a signed copy~~

1 of each radiation safety officer's agreement to be responsible for implementing the
2 radiation safety program, as required in subsection (5) of this section, for the duration of
3 the license. The records shall include the signature of the radiation safety officer and
4 licensee management.

5 ~~Section 11. Radiation Protection Program Changes. (1) A licensee may revise its~~
6 ~~radiation protection program without cabinet approval if:~~

7 ~~(a) The revision does not require a license amendment under Section 5 of this~~
8 ~~administrative regulation;~~

9 ~~(b) The revision is in compliance with 902 KAR Chapter 100 and the license;~~

10 ~~(c) The revision has been reviewed and approved by the radiation safety officer and~~
11 ~~licensee management; and~~

12 ~~(d) The affected individuals are instructed on the revised program before the changes~~
13 ~~are implemented.~~

14 ~~(2) A licensee shall retain a record of each radiation protection program change made~~
15 ~~in accordance with subsection (1) of this section for five (5) years. The record shall include~~
16 ~~a copy of the old and new procedures, the effective date of the change, and the signature~~
17 ~~of the licensee management that reviewed and approved the change.~~

18 ~~Section 12. Supervision. (1) A licensee that permits the receipt, possession, use, or~~
19 ~~transfer of radioactive material by an individual under the supervision of an authorized~~
20 ~~user, as allowed by Section 2(2)(a) of this administrative regulation shall:~~

21 ~~(a) In addition to the requirements in 902 KAR 100:165, instruct the supervised~~
22 ~~individual in the licensee's written radiation protection procedures, written directive~~
23 ~~procedures, administrative regulations of this chapter, and license conditions with respect~~

1 ~~to the use of radioactive material; and~~

2 ~~(b) Require the supervised individual to follow the instructions of the supervising~~
3 ~~authorized user for medical uses of radioactive material, written radiation protection~~
4 ~~procedures established by the licensee, written directive procedures, administrative~~
5 ~~regulations of this chapter, and license conditions with respect to the medical use of~~
6 ~~radioactive material.~~

7 ~~(2) A licensee that permits the preparation of radioactive material for medical use by~~
8 ~~an individual under the supervision of an authorized nuclear pharmacist or physician who~~
9 ~~is an authorized user, as allowed by Section 2(2)(b) of this administrative regulation shall:~~

10 ~~(a) In addition to the requirements in 902 KAR 100:165, instruct the supervised~~
11 ~~individual in the preparation of radioactive material for medical use, as appropriate to that~~
12 ~~individual's involvement with radioactive material; and~~

13 ~~(b) Require the supervised individual to follow the instructions of the supervising~~
14 ~~authorized user or authorized nuclear pharmacist regarding the preparation of radioactive~~
15 ~~material for medical use, written radiation protection procedures established by the~~
16 ~~licensee, the administrative regulations of this chapter, and license conditions.~~

17 ~~(3) A licensee that permits supervised activities under subsections (1) and (2) of this~~
18 ~~section is responsible for the acts and omissions of the supervised individual.~~

19 ~~Section 13. Written Directives. (1) A written directive shall be dated and signed by an~~
20 ~~authorized user before the administration of I-131 sodium iodide greater than 1.11~~
21 ~~Megabecquerels (MBq) (Thirty (30) microcuries (μCi)), any therapeutic dosage of~~
22 ~~unsealed radioactive material or any therapeutic dose of radiation from radioactive~~
23 ~~material.~~

1 ~~(a) If, because of the emergent nature of the patient's condition, a delay in order to~~
2 ~~provide a written directive would jeopardize the patient's health, an oral directive shall be~~
3 ~~acceptable. The information contained in the oral directive shall be documented as soon~~
4 ~~as possible in writing in the patient's record.~~

5 ~~(b) A written directive shall be prepared within forty eight (48) hours of the oral~~
6 ~~directive.~~

7 ~~(2) The written directive shall contain the patient or human research subject's name~~
8 ~~and the following information:~~

9 ~~(a) For any administration of quantities greater than 1.11 MBq (30 μ Ci) of sodium~~
10 ~~iodide I-131: the dosage;~~

11 ~~(b) For an administration of a therapeutic dosage of unsealed radioactive material~~
12 ~~other than sodium iodide I-131: the radioactive drug, dosage, and route of administration;~~

13 ~~(c) For gamma stereotactic radiosurgery: the total dose, treatment site, and values for~~
14 ~~the target coordinate settings per treatment for each anatomically distinct treatment site;~~

15 ~~(d) For teletherapy: the total dose, dose per fraction, number of fractions, and~~
16 ~~treatment site;~~

17 ~~(e) For high dose rate remote afterloading brachytherapy: the radionuclide, treatment~~
18 ~~site, dose per fraction, number of fractions, and total dose; or~~

19 ~~(f) For all other brachytherapy, including low, medium, and pulsed dose rate remote~~
20 ~~afterloaders:~~

(a) What this administrative regulation does: This administrative regulation establishes the requirements and provisions for the medical use of byproduct materials, for issuance of licenses authorizing the medical use of byproduct material and for specific licensees to possess, use and transfer radioactive materials for medical use.

(b) The necessity of this administrative regulation: This administrative regulation outlines the specific qualifications and trainings necessary for the use of byproduct materials for medical purposes. Proper licensing and training helps to ensure the safe administration of radioactive materials during medical treatment.

(c) How this administrative regulation conforms to the content of the authorizing statutes: KRS 211.844 requires the cabinet to promulgate regulations for the registration and licensing of the possession or use of any source of ionizing or electronic product radiation; as well as the specification of the form of applications for registration and licenses, and the qualifications therefor; and to protect the public from unnecessary radiation exposure.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation ensures that all individuals using byproduct materials for medical purposes are properly trained and licensed to do so.

(2) If this is an amendment to an existing administrative regulation, provide a brief summary of:

(a) How the amendment will change this existing administrative regulation: All individuals using radioactive materials for medical purposes must be in full compatibility with the Nuclear Regulatory Commission (NRC) regulations for the medical use of byproduct material. This amendment adopts the NRC regulations where applicable.

(b) The necessity of the amendment to this administrative regulation: Because Kentucky is an agreement state with NRC, the state must ensure state regulations are compatible with NRC regulations. This amendment ensures full compatibility with NRC regulations.

(c) How the amendment conforms to the content of the authorizing statutes: This amendment helps to ensure all professionals engaged in the practice of nuclear medicine are properly trained and licensed to the national standard. This in turn protects those receiving radioactive materials as part of medical therapy.

(d) How the amendment will assist in the effective administration of the statutes: This amendment ensures all entities licensed for the use of radioactive materials in the healing arts are engaged in the safe usage of radioactive materials in their practice consistent with state and federal regulations.

(3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: Approximately 205 specific licensees of the cabinet and all future applicants for specific license authorizing the medical use of byproduct material.

(4) Provide an analysis of how the entities identified in question (3) will be impacted by either the implementation of this administrative regulation, if new, or by the change, if it is an amendment, including:

(a) List the actions that each of the regulated entities identified in questions (3) will have to take to comply with this administrative regulation or amendment: Individuals engaged in the practice of nuclear medicine are required to be in full compliance with NRC regulations.

(b) In complying with this administrative regulation or amendment, how much will it cost each of the identities identified in question (3): There is no anticipated additional cost for regulated entities as a result of this amendment.

(c) As a result of compliance, what benefits will accrue to the entities identified in question (3): By adopting 10 C.F.R. Part 35, the state will eliminate any unnecessary training or licensing requirement for regulated entities.

(5) Provide an estimate of how much it will cost the administrative body to implement this administrative regulation:

(a) Initially: There is no anticipated additional cost to the program to implement this regulation.

(b) On a continuing basis: The program is already operating. There is no cost to implement this administrative regulation.
