The U.S. Nuclear Regulatory Commission (NRC) staff has completed its review of Indiana University/Purdue University Medical Center's Decommissioning Funding Plan and associated cost estimate dated April 17, 2018, for NRC License Numbers 13-02752-03 and 13-02752-08 in accordance with NUREG-1757, Volume 3, Revision 1, "Decommissioning Financial Assurance, Recordkeeping, and Timeliness." Based on this review, the NRC staff has determined that the decommissioning cost estimate, \$3,900,000, is acceptable. Please note that your next cost estimate will be due April 30, 2021.

In addition, NRC staff reviewed the Statement of Intent dated April 11, 2018, and the Certification of Financial Assurance dated April 11, 2018. Based on this review, NRC staff has determined that the financial assurance mechanism and supporting documentation conforms to NRC guidance.

As a result of the approval of the Statement of Intent dated April 11, 2018, we have cancelled and are returning the previously approved Statement of Intent dated August 5, 2003 for License Number 13-02752-03 and the Statement of Intent dated March 25, 2007 for License Number 13-02752-08.
