I was able to speak to our staff in Kentucky. They are not aware of any new mussel resources in the vicinity of your project area so the only new information for the project would be the listing of the rabbitsfoot mussel and critical habitat designation which you already have in your document. You describe the shovelnose sturgeon as federally listed on page 41. While it is listed due to Similarity of Appearance that rule does not apply to the Ohio River where the project is located.

We look forward to reviewing the final EA.
