Changes were made solely to the proprietary designations in these tables.




- 1) The information sought to be withheld from public disclosure involves certain design details in UFSAR tables for the Standardized Advanced NUHOMS® System, which are owned and have been held in confidence by TN Americas LLC.
- 2) The information is of a type customarily held in confidence by TN Americas LLC, and not customarily disclosed to the public. TN Americas LLC has a rational basis for determining the types of information customarily held in confidence by it.
- 3) Public disclosure of the information is likely to cause substantial harm to the competitive position of TN Americas LLC, because the information consists of analytical results related to the design and analysis of dry spent fuel storage systems, the application of which provide a competitive economic advantage. The availability of such information to competitors would enable them to modify their product to better compete with TN Americas LLC, take marketing or other actions to improve their product’s position or impair the position of TN Americas LLC’s product, and avoid developing similar data and analyses in support of their processes, methods or apparatus.
