**Subject:** Status of Request for Additional Information (RAI) Response

**Discussion:** On June 5, 2018, I inquired about the status of EPA's response to NRC's RAI, dated May 1, 2018. Mr. Begluitti requested additional time, which was granted.

On June 12, 2018, Mr. Buschow called on behalf of Mr. Begluitti to discuss Item 1.b. of the RAI, regarding DP details. Mr. Buschow stated that a characterization survey had been performed in 2014 and a Historical Site Assessment (HSA) drafted in 2017. I indicated that these documents would be beneficial so the NRC could determine if a DP would be required, based on the guidance in the NRC NUREG-1757, Consolidated NMSS Decommissioning Guidance, Vol 1, Rev. 2, dated September 2006. Mr. Buschow indicated that he would finalize these documents and submit them.

I verbally extended the due date for the RAI response to June 22, 2018 and rescinded the request for a DP at this time, pending review.

**Action Required:** Wait for RAI Response; complete licensing action.
