NRCB10 BRIEF PROJECT TITLE AND WORK DESCRIPTION

(a) The title of this project is: Symantec Secure Sockets Layer (SSL) Certificates

(b) Background:

Currently, the NRC depends on the Symantec SSL offering to provide server and code signing certificates needed to protect server to server communications. The Symantec SSL service is integrated with existing technology solutions and existing business processes. NRC's specific domains (nrc.gov and nrc-gateway.gov) have previously gone through Symantec's (now owned by Digicert) Domain Validation Process.

(c) Objective:

The objective of this acquisition is to procure Symantec SSL certificate service and support on a brand name only basis from Digicert, Inc. This purchase will be to continue the existing service which was previously provided by the NRC's Information Technology Infrastructure (ITISS) contract under number NRC-33-11-325 with Dell Services Federal Government (DSFG).

(e) Limited Source Justification:

This brand name procurement of the Symantec SSL Service allows the agency to continue to provide SSL certificates to server owners and system administrators at the agency. These certificates allow server-to-server communications to be secured via encryption and are a critical piece of the overall IT security posture of the agency. The Symantec SSL certificates have been tested, secured and is an integral part of the NRC's current enterprise architecture and technical reference model. In addition, the NRC has already completed domain validation processes for its domains (nrc.gov and nrc-gateway.gov).

Even if other COTS software could currently meet the NRC's requirements, the NRC does not currently intend to replace its investment in the Symantec SSL certificates. To do so would cause the NRC to incur significant additional cost, would be highly disruptive and would introduce significant risk to the NRC. Standards for agency software toolsets are

established and maintained for several years to maximize the return on those investments and to minimize disruption to agency operations.
