Dear Mr. Jones:

The U.S. Nuclear Regulatory Commission (NRC) has completed the "Final Environmental Assessment for the amendment of SUA-1341, Ludeman Satellite in Converse County, Wyoming." The final Environmental Assessment (EA) (Agencywide Documents Access and Management System (ADAMS) Accession Number ML18183A225) includes an analysis of relevant environmental issues and documents the NRC staff's determinations regarding the environmental impacts from the construction, operation, aquifer restoration, and decommissioning of the Ludeman Satellite. The NRC also conducted a technical evaluation of the Uranium One license amendment request pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 40, "Domestic Licensing of Source Material," and 10 CFR Part 20, "Standards for Protection Against Radiation." The results of the technical evaluation are documented in a separate Safety Evaluation Report which was made publicly available on March 1, 2018. The technical evaluation and environmental review will inform the NRC's decision on the license renewal request.

In accordance with Title 10 of the *Code of Federal Regulations* Section 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter and the final EA will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of ADAMS.
