Dear Ms. Sandra Talley and Mr. Duncan White,

The Advisory Council on Historic Preservation (ACHP) received an email from Mr. Garrie Kills A Hundred, the Tribal Historic Preservation Officer (THPO) at the Flandreau Santee Sioux Tribe, on Friday May 12, 2017. In this email, Mr. Kills A Hundred is requesting additional information about the U.S. Nuclear Regulatory Commission's (NRC) Agreement State Program and Wyoming's application to join this program, including how historic preservation reviews will be carried out in the future.

As you know, it was the ACHP's advisory opinion that the NRC's Agreement State Program may constitute a federal undertaking subject to Section 106 review at the time it was delegated to the State. Given NRC's determination that this action did not meet the definition of an undertaking and that no Section 106 reviews would be carried out for actions related to this delegation, we ask that the NRC respond directly to Mr. Kills A Hundred's email and questions about the Agreement State Program and Wyoming's application to join this program. Additionally, the ACHP also urges you to ensure that the NRC address this specific topic about the applicability of the Section 106 review process to the Agreement State Program during the upcoming NRC's webinar on the Wyoming Agreement State Application on May 31, 2017.

We think this level of information is relevant to the tribal outreach being conducted for this Wyoming Agreement State Application and anticipate that tribes will benefit from this information.
