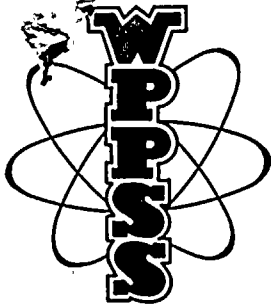

Accordingly, this document should be placed on NRC Docket No. 50-397.

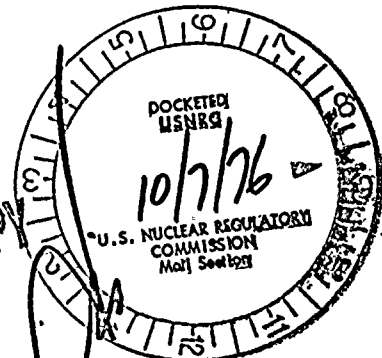
