To Whom it May Concern:

This letter transmits Wolf Creek Nuclear Operating Corporation's (WCNOC) and its owner companies' updated lists of Owners, Officers, Directors and Executive Personnel (OODEP) in respect of the NRC's Foreign Ownership, Control or Influence (FOCI) and Facility Security Clearance for WCNOC and Wolf Creek Generating Station (WCGS).


Under Reference, WCNOC submitted to the NRC its updated OODEP lists for itself, its three owner companies and their two parent companies. Since its submission in March 2015, WCNOC periodically has submitted new updated OODEP information in accordance with 10 CFR 95.17(a) (1) (the thirty-day notices of significant events or changes). Most recently, as you may recall, Westar Energy, Inc. (Westar) and Great Plains Energy Incorporated (GPE) completed a merger that resulted in an indirect license transfer for WCGS. The enclosures incorporate OODEP changes since our March 2015 submission for WCNOC and Kansas Electric Power Cooperative Inc. (KEPCo), and most recent post-merger OODEP lists affected by our ultimate parent company Evergy, Incorporated.
