We now understand that Combustion Engineering has submitted a position outlined to the NRC in their June 30, 1976 letter, from P. L. McGill to B. C. Rusche in which Combustion Engineering proposed adding a Supplementary Protection System to the plant design which is diverse from the present system.

We feel that any further action on our part would not be prudent until the NRC acts on the proposed Combustion Engineering solution outlined in the McGill to Rusche letter of June 30, 1976.
