Last, I request that the NRC reject TVA's effort to reduce the emergency planning zone from 10-miles to 2 miles or less. Should an accident ever occur at the Clinch River Site, the NRC should provide the public with a detailed analysis of how many members of the public could be harmed if these changes in the safety radius are implemented. The safety of our communities should be the NRC's top concern, not the ability for utilities to pursue an experimental technology that is not needed.
