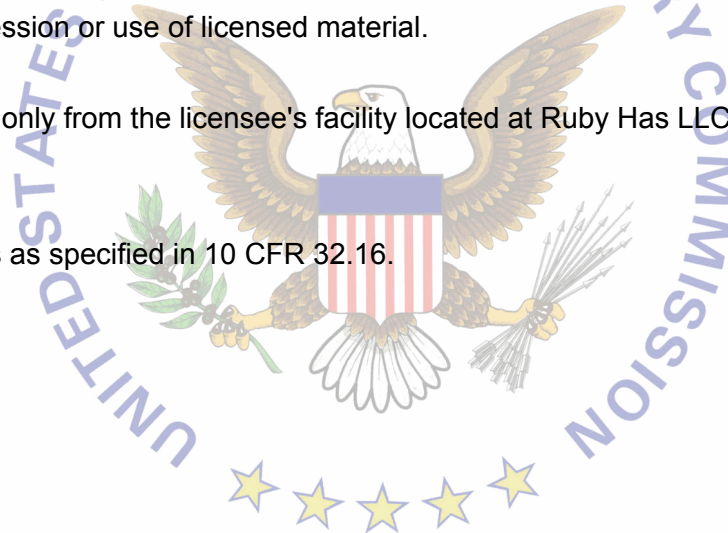

 - A. The timepieces, hands, and dials have been manufactured in accordance with the, International Standards Organization, American National Standards Institute or equivalent industry standard; and
 - B. The amount of tritium on the timepieces, hands, and dials is not in excess of the maximum permissible amounts authorized in 10 CFR 30.15(a)(1).
11. This license does not authorize possession or use of licensed material.
12. Licensed material shall be distributed only from the licensee's facility located at Ruby Has LLC, 400 Heller Park Court, Dayton, New Jersey.
13. The licensee shall file periodic reports as specified in 10 CFR 32.16.
