This refers to your license amendment request dated June 15, 2018. Please find enclosed Amendment No. 39 removing 10 CFR 35.300 materials from the license. In addition, we have noted that you are the individual approved by Delaware Network Imaging to sign and request licensing actions for the facility.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).


