SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-03231/2018-001 AND NOTICE OF VIOLATION

Dear Ms. Davidson:

On May 31, 2018, the U.S. Nuclear Regulatory Commission (NRC) cited Rapid City Regional Hospital, Inc., for one violation, which involved implementing and maintaining written procedures to provide high confidence that each administration was in accordance with the written directive, as required by Title 10 of the *Code of Federal Regulations* (CFR) 35.41(a). The NRC Inspection Report 030-03231/2018-001 with enclosed Notice of Violation required you to respond in writing within 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML18152A892). In a letter dated June 26, 2018 (ADAMS Accession ML18194A840), you provided your response to the Notice of Violation.

After reviewing the information provided in your response to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
