OF VIOLATION

Dear Ms. Lewis:

On July 16, 2018, the U.S. Nuclear Regulatory Commission (NRC) cited Bozeman Health Deaconess Hospital for two violations involving written directives for therapeutic administrations of radium-223. Inspection Report 030-33305/2018-001 with enclosed Notice of Violation required you to respond in writing within 30 days (Agencywide Documents Access and Management System (ADAMS) Accession ML18199A567). You responded by letter dated July 27, 2018 (ADAMS Accession ML18213A248).

After reviewing the information you provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliances described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
