NYSERDA requests a pre-amendment meeting with NRC to discuss the options for the possibility of amending its current license to address NYSERDA's short term goal of site maintenance in potentially contaminated areas of the NRC retained premises and to address NYSERDA's long term goal of updating its license to reflect current site conditions and licensing terms relevant to the Western New York Nuclear Service Center going forward (Agencywide Documents and Management System (ADAMS) Accession No. ML18192C159). NYSERDA plans to discuss at least two options for updating/modifying its license, as follows: (1) convert the current license to a Title 10 of the Code of Federal Regulations (10 CFR) Part 50 possession-only license, with Parts 30 (byproduct material), 40 (source material) and 70 (special nuclear material) authorizations included, as needed to reflect current conditions at the site, and (2) convert the current license to a Part 70 materials license along with Parts 30 and 40 requirements as indicated for the site. The staff is prepared to answer regulatory process questions related to these topics at this meeting. All handouts and specific portions of NYSERDA's draft license amendment application that NYSERDA may plan to provide the staff at this meeting will be added to the public meeting announcement in advance of this meeting.
