SUBJECT: SUMMARY OF JULY 12, 2018, MEETING WITH NEXTERA ENERGY POINT BEACH, LLC, TO DISCUSS SUPPLEMENTAL RESPONSE TO THE REQUEST FOR ADDITIONAL INFORMATION FOR CONTAINMENT DOME TRUSS LICENSE AMENDMENT REQUEST (CAC NOS. MF9532 AND MF9533; EPID L-2017-LLA-0209)

On July 12, 2018, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of NextEra Energy Point Beach, LLC (NextEra or licensee) at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland.

In a letter dated March 31, 2017, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17090A511), as supplemented by two letters dated April 12, 2018, and a letter dated May 29, 2018 (ADAMS Accession Nos. ML18102B164, ML18102B173, and ML18149A466, respectively), the licensee requested an amendment to the renewed facility operating license Nos. DPR-24 and DPR-27 for Point Beach Nuclear Plant, Units 1 and 2, respectively. The proposed amendment uses a risk-informed approach to resolve construction truss design code nonconformances.


The purpose of this meeting was to discuss the licensee's responses in the two letters dated April 12, 2018, to the NRC staff's request for additional information (RAIs) sent by letter dated January 31, 2018 (ADAMS Accession No. ML18025C043). The meeting notice included discussion points prepared by the NRC staff relating to the responses submitted by the licensee. The licensee gave a short presentation (ADAMS Accession No. ML18213A391) on the submittal and the supplemental letters. The NRC staff and the licensee discussed each item from the discussion points and clarification provided by the licensee resolved a majority of the NRC staff's questions. However, the NRC staff determined that additional docketed information is needed related to certain discussion points. This resulted in generation of the second round of RAIs, which were sent to the licensee via email on August 1, 2018 (ADAMS Accession No. ML18214A153).

The meeting notice, including agenda, dated June 21, 2018, is available in ADAMS at Accession No. ML18190A226. A list of the meeting attendees is enclosed.

There were no members of the public in attendance, physically or via bridgeline; and public meeting feedback forms were not requested.
