Mr. Burrows:

Strata has not submitted our responses to the RAIs on the most recent surety estimate. Our initial plan was to have these responses completed by August 7 and we have not been able to achieve that milestone. We have final responses completed for two of the RAIs related to remediation of spill impacts and hole plugging costs (RAIs 2 and 3).

RAI #1 requires additional information on the calculation of flare used to estimate groundwater restoration costs. Strata relies on a consultant hydrologist for this area of expertise and there have been delays on completing that support. I have asked our consultant for a current schedule for completion of the response and expect a reply soon but wanted to respond to you right away. I can provide more detail on the delays related to consultant support in a call if you wish.

At this point Strata can submit the completed responses with an updated schedule for completion of RAI #1 or hold the responses until the entire package is ready to submit. Please let me know which approach you prefer.
