Dear Dr. Shah:

On July 25, 2018, an inspector from the U.S. Nuclear Regulatory Commission (NRC) conducted a routine inspection at your facility in Evansville, Indiana, with continued in-office review through August 6, 2018. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. The in-office review included a review of security-related items. Mr. Luis Nieves of my staff conducted a final exit meeting by telephone with you on August 6, 2018, to discuss the inspection findings. This letter and the enclosed non-public Security Addendum (Enclosure 2) present the results of the inspection.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that one violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation is of a security-related nature. Details of the violation are available in Enclosure 2. The violation is cited in the enclosed, non-public Notice of Violation (Notice) (Enclosure 1). The NRC is citing the violation in the enclosed Notice because the inspector identified it.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. The guidance in NRC Information Notice 96-28, "Suggested Guidance Relating to Development and Implementation of Corrective Action," may be useful in preparing your response. You can find the Information Notice on the

Enclosures 1 and 2 contain Sensitive
