
On May 25, 1978, Marshall Grotenhuis, the NRC project manager for Turkey Point, informed us that a class III fee of \$4,000 was required for the NRC review and acceptance of our submittal dated May 8, 1978 (L-78-168).

Our letter of May 8, 1978 was submitted in accordance with the requirements of Amendment 32 to Turkey Point Facility Operating License DPR-31, dated January 1, 1978 to submit an acceptable analysis of Unit No. 3 beyond six equivalent months of operation. In our opinion, NRC acceptance of our analysis requires neither an amendment to a license nor an approval as defined by 10 CFR 170.2 and 170.3, and therefore does not require a fee to be submitted.

Florida Power & Light Company requests that the NRC's determination that a fee of \$4,000 is required in this case be reconsidered.

In order not to delay NRC acceptance of our submittal of May 8, 1978, a check for \$4,000 is enclosed. ( Check No.51051 ).
