This refers to your license amendment request dated May 11, 2018. Please find enclosed Amendment No. 1 authorizing you as the Radiation Safety Officer and recognizing the license change in mailing address. Also, please note that several changes in your license conditions were made due to an evaluation and correction in your program code from 03124 (Measuring Systems Other) to 03122 (Measuring Systems Analytical Instruments) to more accurately reflect your use of licensed materials. No change in your fee category resulted from this correction.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. 
