**SUBJECT: CAMPCO, INC., REQUEST FOR ADDITIONAL INFORMATION FOR
AMENDING EXEMPT DISTRIBUTION LICENSE 04-23910-01E**

Dear Mr. Slodowitz:

This letter refers to your license amendment letter dated July 25, 2018 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML18226A044 [non-public]). In reviewing your application, we have determined additional information is required to complete our review. In order to continue our review, please address the issues listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) 32.14, "Certain items containing byproduct material; requirements for license to apply or initially transfer."

1. You stated in your letter that three models of tritium sources are used in watch model SWW-1500; however, in your Drawing No. YC 1587, page 2, it only shows two tritium sources. Provide detailed information in technical drawing no. YC1587 of the watch model SWW-1500 to show all sources and model numbers of seal tritium sources that are in the watch.
2. Provide the proposed method of labeling, or marking of each unit and its container with the identification of the manufacturer, or initial transferor, of the product and the byproduct material in the product.
3. Provide the radiation level, and the method of measurement, of each product.
4. Drawing YC1587 does not contain a date or model number of the watch. Please clarify whether this is the final drawing for the watch model SWW-1500.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the NRC may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).
