SUBJECT: ASSESSMENT FOLLOWUP LETTER AND UPDATED INSPECTION PLAN FOR BROWNS FERRY NUCLEAR PLANT, UNITS 1, 2, AND 3 (REPORTS 05000259, 05000260, 05000296/2018005)

Dear Mr. Shea:

As a result of our quarterly review of plant performance, which was completed on August 1, 2018, the U.S. Nuclear Regulatory Commission (NRC) updated its assessment of Browns Ferry Nuclear Plant, Units 1, 2, and 3. The NRC's evaluation consisted of a review of performance indicators and inspection results. This letter informs you of the NRC's assessment of your facility. This letter supplements, but does not supersede, the annual assessment letter issued on February 28, 2018 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML18059A105).

On February 20, 2018, the NRC completed a review of your corrective actions for the greaterthan-green inspection finding in the Security cornerstone, using Inspection Procedure 95001, "Supplemental Inspection for One or Two White Inputs in a Strategic Performance Area." Based on the results of this inspection, the NRC has concluded that you have adequately completed a root cause analysis of the issue, and have identified appropriate corrective actions to prevent recurrence of the issue. No findings were identified concerning the root cause evaluation and corrective actions. The NRC's inspection was documented in NRC inspection report (IR) 05000259, 260, 296/2018440, which is publically available in ADAMS Accession No. ML18051A745.

After reviewing Browns Ferry Nuclear Plant's performance in addressing the greater-than-Green inspection finding subject of this Inspection Procedure 95001, "Supplemental Inspection for One or Two White Inputs in a Strategic Performance Area," the NRC concluded your actions met the objectives of this inspection procedure. Therefore, in accordance with the guidance in Inspection Manual Chapter (IMC) 0305, "Operating Reactor Assessment Program," the greater-than-green finding will only be considered in assessing plant performance for a total of four quarters. As a result, the NRC determined the performance at Browns Ferry Nuclear Plant, Units 1, 2, and 3, to be in the Licensee Response Column (Column 1) of the ROP Action Matrix as of April 1, 2018.

The enclosed inspection plan lists the inspections scheduled through June 30, 2020, for the Browns Ferry Nuclear Plant. The NRC provides the inspection plan to allow for the resolution of any scheduling conflicts and personnel availability issues. Routine inspections performed by resident inspectors are not included in the inspection plan. The inspections listed during the last twelve months of the inspection plan are tentative and may be revised. The NRC will contact you as soon as possible to discuss changes to the inspection plan should circumstances warrant any changes.

In addition to the ROP baseline inspections at your facility, we also plan to conduct Initial License Examinations and TI-191, Inspection of the Implementation of Mitigation Strategies and Spent Fuel Pool Instrumentation Orders and Emergency Preparedness Communication/Staffing/Multi-Unit Dose Assessment Plans.
