On August 9, 2018, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at the Peach Bottom Atomic Power Station, Units 2 and 3. The NRC inspectors discussed the results of this inspection with Mr. Pat Navin, Site Vice President, and other members of your staff. The results of this inspection are documented in the enclosed report.

NRC inspectors documented one finding of very low security significance (Green) in this report. This finding involved a violation of NRC requirements.

If you contest this violation or the significance, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region I; the Director, Office of Enforcement; the Director, Office of Nuclear Security and Incident Response; and the NRC resident inspector at the Peach Bottom Atomic Power Station.

One cross-cutting aspect was assigned to the finding in the area of Human Performance, Procedure Adherence. The finding had a cross-cutting aspect in the area of Human Performance, Procedure Adherence, [H.8], specifically, Peach Bottom failed to follow processes, procedures, and work instructions. If you disagree with the cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region I; and the NRC resident inspector at the Peach Bottom Atomic Power Station.
