SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-33482/2018-001 AND NOTICE OF VIOLATION

Dear Mr. Swan:

On May 31, 2018, the U.S. Nuclear Regulatory Commission (NRC) cited Aaron Swan and Associates for two violations, which involved the failure to (1) ensure that authorized users have successfully completed one of the training courses described in NUREG-1556, Volume 1., Revision 1, dated November 2001; and (2) provide hazmat employees with the training required by 49 CFR 172, Subpart H, at least once every 3 years.

The NRC Inspection Report 030-33482/2018-001 with enclosed Notice of Violation (Notice) required you to respond in writing within 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML18152A990). In a letter dated August 9, 2018, you provided your response to the Notice of Violation (ADAMS Accession ML18221A403).

After reviewing the information provided in your response to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedures," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's ADAMS, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
