**PART I.D -- COMMENTS**

Subsequent to our receipt of your request, we spoke with you about the scope of responsive records. Initially, you clarified that you were seeking training records about CEII or SUNSI. Later, you agreed to narrow your request about SUNSI training records to those that address the SUNSI subcategory of security-sensitive information (i.e., how staff are trained to apply that designation to material they generate or receive). Based on these clarifications, we asked the offices of Nuclear Reactor Regulation (NRR), Nuclear Security & Incident Response (NSIR), Office on New Reactors (NRO), Office of the General Counsel (OGC), Office of the Chief Information Officer (OCIO), and the Office of the Chief Human Capital Officer (OCHCO) to search for any classroom or computer-based training that addresses either how to apply the CEII or SUNSI/ security-related information designations. No responsive records were located by the aforementioned offices.
