UNOPPOSED MOTION TO EXTEND TIME FOR FILING MOTIONS *IN LIMINE*

In accordance with the Atomic Safety and Licensing Board's (Board) Initial Prehearing Order dated February 8, 2013,¹ the NRC staff (Staff) hereby files this unopposed motion² requesting that the Board extend the deadline to file motions *in limine* by two business days, from September 11, 2018, to September 13, 2018.³ On September 5, 2018, the Staff timely filed its rebuttal statement of position and rebuttal testimony, in accordance with the deadline specified in the Board's most recent scheduling order dated May 21, 2018.⁴ The Oglala Sioux Tribe (OST) and Crow Butte Resources, Inc. (CBR) did not file their rebuttal statements of

position and testimony until Friday, September 7, 2018.⁵ Therefore, the Staff did not have the opportunity to start reviewing the rebuttal filings until the morning of September 10, 2018. The Staff requires additional time to review the rebuttal testimony and exhibits, determine whether any portions of those documents should be excluded, and incorporate such requests into a motion *in limine*.

Based on the circumstances described above, and because neither CBR nor the OST oppose this motion, the Staff respectfully requests that the Board extend the deadline for filing motions *in limine* from September 11, 2018 to September 13, 2018.
