#### Dear Ms. Velez,

This is in follow-up to my email dated August 9, 2018 regarding your letter dated August 6, 2018 and documentation you included from 2008 regarding the fee categories assigned to the subject license. You had inquired about whether or not it was appropriate for the NRC to assess fees under the 3P fee category for the nickel-63 gas chromatographs authorized on the subject license.

Please note the Accounts Receivable Branch from the Office of the Chief Financial Officer provided the following information: the OCFO made a mistake in granting the fee waiver for the 3P fee category for USGS in 2008. The OCFO will not retroactively assess fees back to 2008 to collect what should have paid under fee category 3P. The USGS is licensed to use Hydrogen-3, Carbon-14, and Phosphorus-33 with an authorized use of "For use as tracers in biological system studies for research and development as defined in 10 CFR 30.4. They are also licensed to use Nickel-63 with an authorized use of "To be used for sample analysis in compatible gas chromatography devices that have been registered either with NRC under 10 CFR 32.210 or with an Agreement State and have been distributed in accordance with an NRC or Agreement State specific license authorizing distribution". In addition, there are other similar licenses issued to other organizations (e.g., the US Environmental Protection Agency; NRC License No. 34-12736-02; Docket No. 030-13379) who are authorized to use nickel-63 in the same way and they are assessed fees for both the 3M and 3P activities.

As I mentioned in my previous email, your letter indicates that the gas chromatographs you possess are generally licensed (GL) devices. If these devices are currently labelled as generally licensed devices by the manufacturer, you can submit an amendment to remove them from your specific license. If the devices are not labelled as GLs, you can work with the manufacturer to obtain the appropriate GL labels and amend your license accordingly. If you choose to remove the devices from your license, you will need to submit evidence

that the devices are appropriately labelled as GLs. IF you have any further questions regarding this matter, please contact me.
