This submittal provides responses to the Request for Supplemental Information (RSI) forwarded by Reference 2. These responses are based primarily on a clarification call held with the NRC on July 17, 2018 and documented in the conversation record listed in Reference 1. Enclosure 2 provides a response to each of the RSIs listed in Reference 2. Each RSI response has a section stating the impact of the response on the application, both the Technical Specifications (TS) and the Updated Final Safety Analysis Report (UFSAR), indicating which sections, tables, figures, or drawings, have been changed. Enclosure 3 provides a list of additional changes to the UFSAR and TS not associated with the RSI responses. Enclosure 3 is proprietary; a public version is provided in Enclosure 9. Enclosure 4 provides a listing of the CoC 1042 Amendment 1 TS changes, along with a justification, resulting from these RSI responses. Enclosure 5 provides a list of changed TS and UFSAR pages. Enclosure 6 provides a complete update to the

Technical Specifications and UFSAR changes are tracked and indicated by revision bars and italicized text. The new changes associated with the RSI responses are further annotated with rectangles enclosing the changed areas and an indication of which RSI is associated with the changes.

Certain portions of this submittal include proprietary information, which may not be used for any purpose other than to support the NRC staff's review of the application. In accordance with 10 CFR 2.390, TN Americas LLC is providing an affidavit (Enclosure 1) specifically requesting that this proprietary information be withheld from public disclosure. The submittal also includes security-related information.

This submittal is being provided as an electronic submission, using the optical storage media (OSM) provision from Section 4 of the NRC Guidance for Electronic Submissions to the NRC.
