In accordance with your application dated June 29, 2018, requesting U.S. Nuclear Regulatory Commission (NRC) approval of Revision 11 to your physical protection plan, and pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 70, Materials License SNM-1227 is amended to approve the revised plan.

Safety Condition S-1 of your license is amended to add the date of June 29, 2018. Additionally, Safeguards Condition SG-2.1 is amended to specify Revision 11.0 of the Physical Protection Plan.

All other conditions of this license shall remain the same. The amended license and a safety evaluation report is enclosed. This letter concludes staff action on this request and Enterprise Project Identifier L-2018-SPR-0001 is considered closed.
