Dear Mr. Hanson:

On August 2, 2018, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your LaSalle County Generating Station. The NRC inspectors discussed results of this inspection with you and other members of your staff. The results of this inspection are documented in the enclosed inspection report.

The NRC inspectors documented one finding of very low security significance (Green) in this report. This finding involved a violation of NRC requirements. The NRC is treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest these violation(s) or the significance of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region III; the Director, Office of Nuclear Security and Incident Response; the Director, Office of Enforcement; and the NRC resident inspector at the LaSalle County Generating Station.
