Dear Dr. Ricci:

In the letter June 25, 2018, you requested to add Melissa M. Liemkuehler, M.D. as an Authorized User for use of Title 10 *Code of Federal Regulations* (CFR) 35.100, 35.200, and 35.300 material. You also provided the supporting documentation including U.S. Nuclear Regulatory Commission (NRC) Forms 313 A(AUD) and A(AUT) noting that Dr. Liemkuehler is board certified.

On July 26, 2018, I contacted Mr. Anzalone and requested a copy of Dr. Liemkuehler's Board Certificate. After review of the American Board of Radiology (ABR) Certificate for Dr. Liemkuehler, I noted that the certificate cannot be accepted. Specifically, the "AU Eligible" language is not present above the ABR seal as specified in the guidance (the guidance is available at <https://www.nrc.gov/materials/miau/med-use-toolkit/spec-board-cert.html>). I discussed this deficiency with Mr. Anzalone on August 3 and August 6, 2018.

In order to continue with our review, please resubmit Forms 313 A(AUD) and A(AUT) documenting Dr. Liemkuehler's training and experience in use of the requested material.


