Purchase Stand-alone Computer Forensics Software and Maintenance (MNT) Support

Background: The implementation of this product will enable the NRC to reduce its risk from attacks and enable investigation into possible malware exposure and allows for forensics investigations of files and media obtained from NRC personnel on overseas travel. The stand-alone licensed software has the capability to scan the entire hard drive and files for malicious code and help prevent malware from infecting the NRC network and computer. It can be used in a standalone mode used on an individual computer. NRC will use the stand-alone licensed software in evaluating media, searching for or preventing malware infections and on investigative analyses. The FTK Stand Alone licenses software enables the OCIO to perform its mission as outlined under the Federal Information Security Management Act (FISMA) of 2014, and the resulting NIST interpretation detailed in the Special Publication 800-61 Rev 2, “Computer Security Incident Handling Guide.”

(c) **Objective:** The objective of this acquisition is to procure stand-alone Computer Forensics Software and Maintenance (MNT) Support from an authorized NASA SEWP Contractor in a quantity of 3, for a base year and 4 option years beginning 10/01/2018.
