Please find enclosed Amendment No. 8, terminating License No. 47-25566-01 as requested by your NRC Form 314 dated August 27, 2018. This termination is being issued in accordance with the requirements of the applicable NRC Termination Rule in 10 CFR 30.36. All facilities previously used for licensed activities may be released for unrestricted use. However, we understand that the gauges included in this specific license were transferred to Berthhold Technologies, USA, LLC, who subsequently redistributed the gauges to you under a general license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).
