Dear Mr. Macmanus:

The U.S. Nuclear Regulatory Commission (NRC) is currently undergoing an internal review of license program codes. Program codes are used by the NRC to designate the activities or authorized uses of the material under your license. Program codes are tied to the fee categories described under Title 10 of the *Code of Federal Regulations* (10 CFR), Part 171, "*Annual Fees for Reactor Licenses and Fuel Cycle Licenses and Materials Licenses, Including Holders of Certificates of Compliance, Registrations, and Quality Assurance Program Approvals and Government Agencies Licensed by the NRC,*" which determine annual fee amounts for our licensees.

Through the course of our internal review, program codes assigned to your license and materials and activities authorized on your license were reviewed against our current list of active program codes. As a result of the review, the applicable program codes have been updated on your license, and the resulting fee categories for your license are now 3O and 3P. These fee categories result in an expected annual fee of \$33,600, per the fiscal year 2018 Fee Rule. Please note that fees are adjusted on an annual basis depending on fee category amounts established in each year's fee rule.
