

CHANGE-OF-NAME AGREEMENT

Orano Federal Services LLC (Contractor), a limited liability company duly organized and existing under the laws of Delaware [*insert State*], and the United States of America (Government), enter into this Agreement as of February 16, 2018 [*insert date when the change of name became effective under applicable State law*].

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers of the US Nuclear Regulatory Commission (NRC), Department of Energy (DOE) [*insert name(s) of agency(ies)*], has entered into certain contracts and purchase orders with AREVA Federal Services LLC, as shown in the attached list marked "Exhibit A" and incorporated in this Agreement by reference. 
