This refers to your license amendment request dated September 13, 2018. Please find enclosed Amendment No. 32 removing the authorization for Iodine-131 therapy as requested. We also note that you are no longer utilizing Xenon-133 for ventilation scans.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. 
