A RESCLUTION

WHEREAS, the Alabama Rural Electric Association consists of 23 rural electric cooperatives throughout the State of Alabama. Eight of these cooperatives are Tennessee Valley Authority power distributors, serving approximately 96,000 consumers in North Alabama. A major activity of this organization is providing and protecting an adequate power supply for the people in our service area; therefore, we are vitally concerned that the Tennessee Valley Authority be permitted to operate its Browns Ferry units one and two, and,

WHEREAS, if the Tennessee Valley Authority is not permitted to load fuel and test units one and two immediately, this 2,200 megawatts of power will not be available for the summer load peaks and the Tennessee Valley Authority's system will not have sufficient capacity along with necessary operating reserves to assure an adequate power supply for its service area, and,

WHEREAS, the Tennessee Valley Authority will be required to contract for the necessary power, if available, from other systems to insure an adequate supply. This additional power supply will cost the consumers of Tennessee Valley Authority power an additional 70 million dollars;

NOW THEREFORE BE IT RESOLVED, that the Alabama Rural Electric Cooperative Association petitions the Nuclear Regulatory Commission of the United States of America, in the interest of its members and others, that the Tennessee Valley Authority be permitted to fuel and start tests on Prowns Ferry units one and two.
