Dear Ms. Sparks:

Enclosed is Amendment No. 22 to your NRC Material License No. 13-15544-01 in accordance with your request. Note that the format of your license has changed due to our updated licensing process.

Items 6-9 on your license have been updated in accordance with your request and the applicable Sealed Sources and Devices Registries; note that device manufacturer names have been updated to the current company names registered with the NRC or Agreement States.

Additionally, the following License Conditions have been updated in accordance with our licensing policy: Condition 11 regarding the requirement that authorized users be designated in writing by the Radiation Safety Officer, Condition 13 regarding the leak test requirements for sealed sources, Condition 15 regarding the biannual inventory requirement, and Condition 16.B. regarding records retention for shutter leak test results. Condition 13.B., as described on Amendment No. 21, describing leak test requirements for alpha particle emitting sealed sources has been deleted as it is not relevant to the type of material authorized on this license. Lastly, Condition 24, as described on Amendment No. 21, regarding transportation requirements has been deleted as these requirements are already specified in the regulations in 10 CFR Part 71.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. You can access the policy
