Dear Mr. Nazar:

By letters dated January 30, 2018, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML18037A812), February 9, 2018 (ADAMS Accession No. ML18044A653), February 16, 2018 (ADAMS Accession No. ML18053A123), March 1, 2018 (ADAMS Accession No. ML18072A224), and April 10, 2018 (ADAMS Accession Nos. ML18102A521 and ML18113A132), Florida Power & Light Company (FPL) submitted an application for subsequent license renewal of Renewed Facility Operating License Nos. DPR-31 and DPR-41 for the Turkey Point Nuclear Generating Unit Nos. 3 and 4 (Turkey Point) to the U.S. Nuclear Regulatory Commission (NRC) pursuant to Section 103 of

the Atomic Energy Act of 1954, as amended, and Part 54 of Title 10 of the *Code of Federal Regulations*, "Requirements for renewal of operating licenses for nuclear power plants".

The NRC staff from the Divisions of Materials and License Renewal (DMLR), of Engineering (DE), and of Safety Systems (DSS) is reviewing the information contained in the subsequent license renewal application and has identified, in the enclosure, areas where additional information is needed to complete the review.
