In the referenced letter, Global Laser Enrichment, LLC (GLE) submitted the following documents in support of its request for reaccreditation of the GLE Program Cyber Security Plan and the network operation and continued Authorization to Operate (ATO): (1) *Program Cyber Security Plan Engineering and Industrial Control System Environments for the GE Hitachi Global Laser Enrichment LLC Wilmington, NC Facilities,* GLEP-00015-R, Revision 6: (2) *Program Cyber Security Plan Security Test and Evalution* [sic] – *GLE Engineering and Industrial Controls Environments for the GE Hitachi Global Laser Enrichment LLC Wilmington, NC Facilities,* GLEP-00017-R, Revision 5; and (3) Classified Distributive Information Network (CDIN), GLEP-00023-R, Revision 8.2.

The Department of Energy Nuclear Energy Oak Ridge Site Office, acting as the Authorizing Official (AO) for the GLE classified cyber networks, approves both Program Cyber Security Plans identified as GLEP-00015-R, Revision 6, and GLEP-00017-R, Revision 5, as well as the CDIN, GLEP-00023-R, Revision 8.2. Based upon this approval, GLE is authorized to operate the network identified in these Program Cyber Security Plans and CDIN for the processing up to and including Secret Restricted Data for three (3) years from the date of this letter. To maintain this ATO, the continuous monitoring report must be submitted to the AO at least annually.
